OFFICIAL RULES

NO PAYMENT OR PURCHASE NECESSARY TO ENTER. PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID OUTSIDE THE 50 UNITED STATES AND WASHINGTON, D.C. AND WHERE RESTRICTED, TAXED OR PROHIBITED BY LAW.

1. **ELIGIBILITY:** Open only to legal residents of the 50 United States and Washington, D.C., who are 13 years of age or older as of date of entry. Void where prohibited, taxed or restricted by law.
